Child Protection & Safeguarding Statement

All schools are required to ensure they adhere to statutory safeguarding procedures in order to keep children safe in and out of school and to promote their welfare.

Primary Schools and Prevent

PREVENT is a national strategy which includes supporting schools with educating and safeguarding pupils against the dangers of radicalisation and violent extremism .

At Grange Primary School, we believe that children should be given the opportunity to explore the issues of diversity and understand Britain as a multi-cultural society. Providing a safe learning environment in which children can raise controversial questions and concerns without fear of reprimand or ridicule and explore boundaries of what is acceptable will engender an open attitude to multi-cultural and race issues.

We aim to explore issues of diversity and multi-culturalism through our PSHE curriculum, drawing on resources from the PSHE organisation and Prevent 4 Schools, which are built into our curriculum and studied throughout the year, alongside our developing work as a Rights Respecting

The DfE publication 'Mental Health & Behaviour in Schools (2018) states:

'Schools have an important role to play in supporting the wellbeing of their pupils, by developing approaches

tailored to the particular needs of their pupils.

The school role in supporting and promoting mental health and wellbeing can be summarised as:

- Prevention
- Identification
- Early support
- Access to specialist support'

In our school, we have the following in place to promote good mental health and behaviour:

- Positive Behaviour Management Policy, with clear routines, rewards, boundaries and sanctions
- Pastoral Support advice provided to all staff and pupils by Mrs Sutton, who is ELSA trained and accredited (Emotional Literacy Support Assistant)
- Specific and focused training for staff , which includes ACEs (Adverse Childhood Experiences), Mental Health & Anxiety in Young People (provided by LEHSS)
- Trained Youth MHFA staff

Operation Encompass is a unique Police and Education early intervention safeguarding partnership which ensures that a child's school is informed, prior to the start of the next school day, that there has been an incident of Domestic Abuse to which the child or young person has been exposed, and which might then have an impact on them in school the following day.

The partnership recognises that all incidents of Domestic Abuse can be harmful to children and young people.

A nominated member of staff, known as a Key Adult, has been trained to liaise with the police. At Grange Primary School our Key Adult is Ms C Taylor, Headteacher.

The Key Adults will keep this information confidential, and will only share it on a need to know basis, for instance, to teaching staff for the child or young person. It will not be shared with other school students.
